Special Arrangements:	Any use of outside contractors including decorations or delivery plans must be proposed in advance to Red for confirmation. Subject to amendment and final approval by Red.									
Confirmation & Deposit:	In order to secure a booking, a signed agreement and 50% deposit of the minimum spending must be received or Red reserves the right to cancel reservation. Deposit is non refundable or non-transferable except in the case of a Force Majeure event.
